Minimum Qualifications

- 1. Candidate will be required to pass a drug & alcohol screening.

- 4. Candidate must have a good work history, show up for work on time and complete work assignments.

Knowledge, Skills, and Abilities

- 1. Candidate must possess a working knowledge of gear man duties and responsibilities related to Sideloader and Lo/Lo vessels.
- 2. Candidate must be knowledgeable in all of Mid Atlantic Terminal's Gear to include but not limited to; maintenance and care of slings and their attachments. (chains, shackles, pneumatic hooks, etc.), head clamps, Jensen Gear, Lifting Gear of all types.

- 5. Candidate will be required to wear proper PPE: OSHA compliant safety vest, safety toe boots, hardhat, and long pants.

- 7. Candidate must demonstrate the ability to communicate verbally and in writing.
- 8. Candidate must possess the ability to follow, and carry out instructions in either, written or oral form.
